

## Board of Directors, Workshop/Special Meeting Minutes, Monday, December 6, 2021 RICHLAND SCHOOL DISTRICT NO. 400 BENTON COUNTY, RICHLAND, WASHINGTON

The Board of Directors of Richland School District No. 400 met for a Workshop/Special Meeting Monday, December 6, 2021 via Zoom and in person at 6972 Keene Road, West Richland, Washington, Benton County. School Board President Jill Oldson presided. Board members present: Rick Jansons, Kari Williams, Semi Bird, and Audra Byrd.

Ms. Oldson called the meeting to order at 4:30 P.M.

## 1.0 Washington State School Directors' Association Debrief

Mr. Jansons was recognized as the out-going President of WSSDA. Mr. Jansons shared the legal requirement for School Board Directors training regarding Diversity, Equity and Inclusion. After discussion, Board members asked for a workshop with local consultants to review District staff training earlier this year.

Board members shared information on break out sessions each attended. All sessions were recorded for access after the conference and recommendations were discussed. A Workshop is planned in January where Tricia Lubach, WSSDA Director of Leadership Development, will continue work on Board Operating Principles.

## 2.0 Board Agenda Planning Discussion
