

Board of Directors, Regular Meeting Minutes, Tuesday, December 13, 2022 RICHLAND SCHOOL DISTRICT NO. 400 BENTON COUNTY, RICHLAND, WASHINGTON

The Board of Directors of Richland School District No. 400 met for a regular meeting Tuesday, December 13, 2022, at 6:30 P.M. via Zoom and in person, 6972 Keene Road, West Richland, Washington. School Board President Jill Oldson presided. Board members participating: Kari Williams, Semi Bird, Audra Byrd, and Rick Jansons. Administrators present: Superintendent Dr. Shelley Redinger, Assistant Superintendent of Elementary Education Brian Moore, Executive Director of Information Technology Mike Leseberg, Executive Director of Operations Richard Krasner, Executive Director of Teaching and Learning Jennifer Klauss, Executive Director of Special Education 6-12 Robert Sorensen, Executive Director of Special Education Pre-K-5 Zach Carpenter, Executive Director of Behavioral Health Services Tory Christensen, and Director of Communications Ty Beaver.

The Board meeting was called to order at 7:42 P.M. after some technical difficulties.

1.0 CALL TO ORDER

- 1.1 Pledge of Allegiance
- **1.2 Roll Call-**Mr. Jansons will be arriving after a school/family event.

2.0 COMMUNICATIONS

2.1 GOOD NEWS-Benton Franklin Transit/Community Based Transition Classroom (CBTC) Award

Sophie, Brannick and Samantha, CBTC students, presented an award to several of the Benton Franklin Transit drivers in attendance. Laurie Price, CBTC Teacher, advised students would not be able to get to and from their job sites without this service.

2.2 Requests and Comments by Visitors (2 minutes per individual)

Sara Flores-Anderson, Teacher, advised staff members want parents to participate on curriculum committees, but sometimes it is not possible to include the one third amount requested in the policy presented due to the number of specialists, staff members, and the number of parents/community members willing to volunteer.

Cheyenne Laviolette, Teacher, shared a positive relationship with a teacher that shaped her life. Ms. Laviolette feels pride flags should be allowed in classrooms since some students find these to be safe spaces.

Krista Calvin, REA President, thanked the Student Representatives for offering the flag survey to students and hopes their viewpoint won't be ignored. Ms. Calvin also thanked Ms. Oldson for her service as President and stated concerns regarding other issues on the agenda.

Tina Gregory, non-district resident, stated hate speech is up to the individual and asked to allow all religions back in schools.

Virginia Tomlinson, Pasco, spoke in support of the LGBTQ+ community and wants to make school a safe place for all students.

Dusty Howard, Richland, shared concern with Policy 2331-Controversial Issues, and stated the American Civil Liberties Union (ACLU) offered assistance and feels Board members should take this advice.

3.0 UNFINISHED BUSINESS

3.1 Flag Survey Report

Karrin Wierzchowski, Student Representative, shared the results of a survey sent to students at all Richland High Schools. Ms. Wierzchowski stated more than 1,400 students responded. She also thanked fellow Student Representative, Leif Carman, for his help with this project. Questions included:

Do flags depicting political signs make you uncomfortable?

- 17.8% flags made them feel uncomfortable
- 82.2% flags did not make them feel uncomfortable

Do you feel safe or unsafe in a classroom displaying flags?

- 58% felt safe
- 35.8 impartial
- 5.5% felt unsafe

Have your ever felt un-welcome or intimidated because of certain flags in a classroom?

- 17.9% Yes
- 82.1% No

Board discussion followed.

4.0 NEW BUSINESS

4.1 Performance Audit Update

Superintendent Redinger advised the District's Custodial Team is beginning a series of trainings through the Cleaning Management Institute. This training will assure that buildings are being cleaned to national standards. Seventeen Building Foremen will participate in this training by the end of summer.

Mr. Jansons arrived.

4.2 Policy/RR No. 6700-Nutrition, Health, and Physical Education-First Reading

Galt Pettett, General Counsel, stated the state passed House Bill (HB) 1878-School Meals. Mr. Pettett stated this legislation is an "essential" policy and requires public school districts to group their schools in a manner that maximizes the Community Eligibility Provision (CEP) in the National School Lunch Program. A major change is the requirement of a District Wellness Committee including staff, local officials, food authority members, and community members.

Ms. Byrd requested to add that students not be held back from recess or to complete classwork as discipline. Discussion followed.

It was moved by Semi Bird and seconded by Audra Byrd -

THAT THE BOARD OF DIRECTORS APPROVE POLICY/RR NO. 6700-NUTRITION, HEALTH, AND PHYSICAL EDUCATION FOR FIRST READING.

Vote: Bird, yes; Jansons, yes; Williams, yes; Byrd, yes: and Oldson, yes. Motion was approved.

4.3 Board of Directors Election of Officers

Ms. Oldson shared the procedure regarding Board Election of Officers and asked Board members if they would stand for the Office of President.

• Bird: no; Jansons, no; Williams, yes; Byrd, no; Oldson, no.

Ms. Oldson announced Ms. Williams will serve as President.

Ms. Oldson asked if Board members would stand for the Office of Vice President:

• Bird, no; Janson, no; Oldson, yes; Byrd, yes; Williams, no.

Ms. Oldson voted for herself; Ms. Byrd voted for herself; Ms. Williams for Ms. Byrd; Mr. Jansons voted for Ms. Oldson; and Mr. Bird voted for Ms. Byrd. Ms. Oldson announced Ms. Byrd will serve as Vice President.

Mr. Bird will continue as the District's Legislative Representative since this was a two-year posting. Ms. Williams took the gavel as the new President of the Board of Directors.

4.4 Curriculum Committee Procedures-First Reading

Ms. Byrd shared an update to the Curriculum Committee Procedure after a recent meeting with Jen Klauss and Derek Okonek, Executive Directors of Teaching and Learning. Ms. Williams requested the Superintendent be part of the selection process when more applicants from the community apply for curriculum committees, along with two Board members. Board discussion followed.

It was moved by Jill Oldson and seconded by Semi Bird –

THAT THE BOARD OF DIRECTORS APPROVE CURRICULUM COMMITTEE PROCEDURES POLICY WITH THE ADDITION OF "THE SUPERINTENDENT" AND TWO BOARD MEMBERS FOR FIRST READING.

Vote: Bird, yes; Jansons, yes; Williams, yes; Byrd, yes: and Oldson, yes. Motion was approved.

4.5 Student Discipline Workshop Planning Discussion

Ms. Byrd shared a list of expectations/topics for the upcoming Board Workshop regarding discipline/student behavior including: current process, a model policy/procedure, and data in regard to current behaviors reported. Others added: legal aspects, contracts, interpretations. There was agreement the first workshop would review current policy/procedures. Several workshops will be needed to research this topic. Dr. Redinger advised this will take some time since principals need to share feedback. Policies from other districts should also be researched. The first workshop will be held on January 4, 2023 at 4:30 P.M.

4.6 Student Representative Advisory Vote

Ms. Oldson asked to bring this topic to the Board after researching other districts that allow Student Representatives to cast an advisory vote on topics during Board meetings. The votes do not change the outcome of votes by Board members, but rather helps to share student voice on agenda items.

It was moved by Jill Oldson and seconded by Rick Jansons -

Discussion:

Mr. Bird feels this is already happening since students are asked to share their opinions. Mr. Jansons is in favor of the idea and feels this will enlarge their experience when speaking in front of an audience. Ms. Byrd and Ms. Williams shared concern for students and asked the community to be kind.

Student Representatives, Karrin Wierzchowski and Leif Carman, were both in favor of having an advisory vote stating student opinions do matter.

THAT THE BOARD OF DIRECTORS ALLOW THE STUDENT REPRESENTATIVES TO THE BOARD OF DIRECTORS AN ADVISORY VOTE ON AGENDA TOPICS.

Vote: Bird, yes; Jansons, yes; Williams, yes; Byrd, yes: and Oldson, yes. Motion was approved.

4.7 Policy No. 2331-Controversial Issues-First Reading

Ms. Byrd shared a draft update to Policy No. 2331-Controversial Issues, with the Board and agreed with the change to add free from prejudice "and political bias" in the first paragraph and the addition of:

Regarding this policy, controversial issues can be defined as:

- 1. Not included in the district approved curricula.
- 2. Covered in the local newspaper within the last three years.

Ms. Williams also shared a draft update including the addition of "and political bias" in the first paragraph and the addition of:

Regarding this policy, controversial issues can be defined as topics that are not included in the district curricula and/or topics that deal with questions of values, beliefs, lifestyles, and can divide opinion between individuals, communities, and wider society.

It was moved by Rick Jansons and seconded by Jill Oldson –

THAT THE BOARD OF DIRECTORS APPROVE THE CURRENT POLICY NO. 2311-CONTROVERSIAL ISSUES WITH THE ADDITION OF "AND POLITICAL BIAS" IN THE FIRST PARAGRAPH.

Discussion:

Mr. Jansons feels the District has a process in place to deal with controversial issues for resolution by contacting the teacher, then to the principal if needed.

Mr. Bird likes being objective, engaging parents, and feels the guidance from the ACLU should be taken seriously.

Ms. Oldson prefers not having the definition defined since it is different for everyone. Checks and balances are already included, and she feels teachers and principals exercise professional judgement.

Ms. Byrd feels a definition is needed to assist teachers and principals. Staff can easily see if topics are in the District curricula or in the local newspaper. Ms. Byrd feels this will provide an objective measurement. More discussion followed.

Leif Carman, Student Representative, feels teachers have done a good job using professional judgement, and is against defining controversial issues as it will cause confusion.

Vote: Students - Leif, yes; Karrin, yes

Vote: Bird, no; Jansons, yes; Williams, no; Byrd, no: and Oldson, yes.

Motion failed.

It was moved by Audra Byrd and seconded by Semi Bird -

THAT THE BOARD OF DIRECTORS APPROVE POLICY No. 2331 WITH THE ADDITIONS PROVIDED BY MS. BYRD ABOVE FOR FIRST READING.

Vote: Bird, yes; Jansons, no-sharing an example. Mr. Bird asked for Point of Order.

Discussion was opened again. There was none.

Vote: Bird, yes; Jansons, no; Williams, no; Byrd, yes: and Oldson, no. Leif, no; Karrin, no. Motion failed.

It was moved by Semi Bird and seconded by Kari Williams –

THAT THE BOARD OF DIRECTORS APPROVE POLICY No. 2331 WITH THE ADDITIONS PROVIDED BY MS. WILLIAMS ABOVE FOR FIRST READING.

Discussion-Ms. Byrd amended the motion to remove the word "or". The motion was seconded by Semi Bird.

Discussion on the amendment to the motion: None

Leif, no, Karrin, yes

Vote: Bird, yes; Jansons, no; Williams, yes; Byrd, yes: and Oldson, abstained.

Motion was approved.

It was moved by Semi Bird and seconded by Kari Williams –

THAT THE BOARD OF DIRECTORS APPROVE POLICY No. 2331 WITH THE ADDITIONS PROVIDED BY MS. WILLIAMS ABOVE WITH EXCEPTION OF THE WORD "OR" FOR FIRST READING.

Vote: Bird, yes; Jansons, no; Williams, yes; Byrd, yes: and Oldson, no. Leif, no, Karrin, no Motion was approved.
