Additional Completion Information



Sometimes attending the class on Zoom is enough to satisfy the requirements for the FCS class. However, there are certain times when you will need to complete additional work to satisfy the requirements. There are six classes that require more than attending a zoom class. As a reminder, submit all completion records to Jennifer Miller. She will update your completion records. All completion records must have your name and the date of completion clearly visible on them.

Completing FCS 03: In addition to attending the zoom class, you will need to also need to complete modules 5 and 7 from What We Do Matters modules on OSPI site. The directions for logging into this site were shared in the last FCS newsletter. Once you have completed BOTH modules, please send either a printed version or a screen shot of the course completion certificate for each module to Jennifer Miller. She will update your completion records. You will not get credit for this class without attending the zoom class AND completing the two modules.

Completing FCS 04: You can complete this without attending a zoom class at all. Instead, you will need to complete module 8 from What We Do Matters modules on OSPI site. The directions for logging into this site were shared in the last FCS newsletter. Once you have completed this module, please send either a printed version or a screen shot of the course completion certificate to Jennifer Miller. She will update your completion records.

- Bloodborne Pathogens Exposure Prevention: Full course- Including HIV (Washington)
- Health Emergencies: Asthma Awareness (full course, Washington)
- Health Emergencies: Life-Threatening Allergies (full course, Washington)
- Child Abuse: Identification & Intervention (full course)
 - Choose one of the following combinations:
 - Bloodborne Pathogens + Asthma + Allergies, *or*

Please make sure know what is required for each class so you get credit for you work.
